Irmgard Marboe is Associate Professor of International Law at the Department of European, International and Comparative Law, Section for Public International Law and International Relations, at the Faculty of Law of the University of Vienna. She studied law and Roman languages at the University of Vienna (Austria) and at the Universidad Complutense de Madrid (Spain). Her doctoral thesis (1994) dealt with legal aspects of cultural subsidies under European Community Law (State aid, prohibition of discrimination, taxation). Her post-doctoral thesis ("habilitation") entitled "Die Berechnung von Entschädigung und Schadenersatz in der internationalen Rechtsprechung" was published by Peter Lang and in an abridged version in English with the focus on investment law by Oxford University Press in 2009 ("Calculation of Compensation and Damages in International Investment Law"). A second edition is in preparation (planned publication in 2017). As associate editor of the online journal Transnational Dispute Management (TDM) she edited a special issue on "Compensation and Damages in International Investment Arbitration". Currently, she is the Co-Editor-in Chief of the "Journal on Damages in International Arbitration". As an expert in international investment law she is invited to numerous events and publication projects in Austria and abroad and gives advice to Austrian and foreign law firms.

Another research focus is the international law of outer space. Since 2008, Irmgard Marboe is the head of the Austrian National Point of Contact for Space Law (NPOC) of the European Centre for Space Law (ECSL) supported by the Austrian Research Promotion Agency (FFG) and the Federal Ministry of Transport, Innovation and Technology (see <u>www.spacelaw.at</u>). Between 2009 and 2015, she gave advice to the Federal Ministry of Transport, Innovation and Technology for the drafting of the Austrian Space Law (BGBI I Nr. 132/2011) and the Austrian Space Regulation (BGBI II Nr. 36/2015). Between 2008 und 2013 she was the chair of the Working Group on "National Space Legislation" of the Legal Subcommitte of the UN Committee for the Peaceful Uses of Outer Space (UNCOPUOS), whose work resulted in the adoption of the UN General Assembly Resolution No 68/74 of 11 Dezember 2013 entitled "Recommendations on National Legislation Relevant to the Peaceful Exploration and Use of Outer Space".

Other publications deal with Islamic law and international law as well as with the relationship of religion, law and the State. Since 2008, she is the director of the Vienna International Christian-Islamic Summer University, mainly supported by the Austrian Federal Ministry of Science and Research and organised under the auspices

of the University of Vienna. It takes place on a biannual basis in Stift Altenburg, Lower Austria (see <u>www.vicisu.com</u>). Since 2013, she is Co-Rapporteur of the Committee *"*Islam and International Law" of the International Law Association (ILA).

Her teaching activities include lectures, courses, exercises and seminars on general international law, international courts and tribunals, and space law in German and English at the University of Vienna. In addition, she teaches regularly at the Danube University Krems, the University of Applied Sciences at Krems and at the Webster University, Vienna Campus. Short-term stays as a visiting lecturer brought her to Slovakia, Denmark, Sweden, Saudia Arabia and the United States.

She speaks German, English, French, Spanish and Italian.
